Public is cordially invited to attend. Art works must remain on display at the Fine Arts Center through Saturday, May 21, no exceptions. Artists removing any work prematurely will not be permitted to enter the 2012 show. Pick up of artwork is on Saturday, May 21 from 10am -2 pm.

Art work cannot have previously been entered in a PFAA Spring Competition.

CATEGORIES: Include, but may not be limited to:

Oil and Acrylic

Watercolor and Tempera

Drawing – pen & ink, charcoal, pastel, graphite and colored pencil

Dimensional – pottery/ceramic, stained glass, etc.

Photography

AWARDS: Cash awards will be given in each of the categories

First Place \$ 75.00

Second Place \$ 50.00

Third Place \$ 25.00

Best of Show \$100.00

There will an Honorable Mention Ribbon given in each category as well

Purchase Award up to \$200 by The Paulding Fine Arts Association

ENTRY RULES:

- Entrants must be Paulding County residents or Paulding Fine Arts Association member and be 18 years of age or older.
- All works must be exhibiting artist's original work, and not a reproduction of another artist's work, including photographs
- **All work MUST be framed and wired, ready for hanging. Saw-tooth hangers will NOT be accepted** (Gallery wrapped canvases need not be framed, but sides must be painted)
- The Paulding Fine Arts Association has the right to reject any work due to subject matter
- Security will be provided, however, The Paulding Fine Arts Association, nor the City of Dallas, will be held responsible for lost, stolen or damaged items.
- All work must have been completed within the last two years and not previously entered in the Annual Competition.
- A 25% commission/fee will be charged for any piece of art sold during the show. Buyers will be able to take possession of the work at the end of the exhibit.

ENTRY FEE: \$25.00 for the first work and \$5.00 each for each additional work. Limit of three works.

***PFAA members will enjoy a reduced entry fee-must be a member prior to entry date.***

JUDGES: Three independent, professional judges will be selected to judge the competition.

DELIVERY: Deliver art works to the Fine Arts Center on **Saturday, April 16<sup>th</sup>** between 9:00am and 12:00 noon

**PICK UP: Saturday, May 21, 2011**

**DEADLINE:** Entry fee and application must be received with delivery of art on **Saturday, April 16<sup>th</sup>**  
(Checks should be made payable to The Paulding Fine Arts Association OR to PFAA)

See second (2<sup>nd</sup>) page for entry forms – these forms must be completed, with appropriate portion of form attached to the **LOWER LEFT HAND BACK CORNER OF THE WORK** for hanging work, or adhered to the bottom of dimensional sculptures, pottery and other work. Please have paper work completed beforehand.
